COOPERATION AGREEMENT

BETWEEN UNIVERSIDAD NACIONAL DE ASUNCIÓN, REPUBLIC OF PARAGUAY

AND

UNIVERSITY OF ECONOMICS IN KATOWICE, REPUBLIC OF POLAND

Universidad Nacional de Asunción hereinafter UNA with registered address at Avda. España 1098, 910 Asunción, Paraguay, represented by its Rector, Prof. Ing. Agr. PEDRO GERARDO GONZALEZ GONZALEZ as one party, and University of Economics in Katowice, hereinafter UEK, with registered address at ul. 1 Maja 50, 40-287 Katowice, Poland, represented by its Rector, prof. Leszek Żabiński, establish to sign this Cooperation agreement in accordance with the laws of each country and the rules of international law, consisting of the following terms and conditions:

ARTICLE ONE: The purpose of this agreement is to establish mutual cooperation between UNA and UEK.

ARTICLE TWO: Both institutions commit to give the required priority to the development of research projects and technological developments in their respective extent areas

ARTICLE THREE: Data exchange, skills and scientific information will be made broadly and it will be a permanent commitment between UNA and UEK.

ARTICLE FOUR: The signing institutions of the present agreement commit to cooperate in the areas of teaching, student exchange, research, extracurricular activities in order to provide the best environment to develop, promote and display the achievements within the present Cooperation agreement.

ARTICLE FIVE: Any aspect relating to the functions, duties and / or responsibilities of the parties, which is not covered in this Cooperation agreement, and any doubt or differences, will be defined through addenda.

ARTICLE SIX: This Cooperation agreement does not exclude the signing of bilateral or multilateral agreement between the signatory's institutions not only with private or public entities but also with national or international institutions in order to perform similar and or supplement activities.

ARTICLE SEVEN: The implementation of this actions will be carried out through specific agreements or attached annexes previously approved in written by the parties. Each and every specific agreement will nominate one representative and a substitute who will officiate as a link between the both institutions for planning and coordination of the activities to be developed and that are the reason for this Agreement.

ARTICLE EIGHT: This cooperation agreement will become effective as of the date of its signature and will have a 5-year duration that may be extended for equal periods automatically. It can be revoked or amended by mutual agreement of the parties, at the request in written by of one of them, 40 days before the date of conclusion of this agreement.

ARTICLE NINE: In case of any difficulty interpreting or executing the Agreement it will be solve by direct negotiation.

In conformance and acceptance of each and every one of the clauses of this agreement, two (2) exact copies with the same purpose are signed in the city of San Lorenzo, on the day 20 of February, 2014.
